FURTHER RESOLVED, the Board extends its greatest thanks to Dave and his wife for their support of our cause over many years and wishes him the best in future endeavors.

A discussion of 2017 priorities and initiatives followed.

The following resolution was approved unanimously:

WHEREAS, the Revere's Riders Carbine program has been effective and safe, WHEREAS, the Instructor Upgrade Procedures exceed the NRA America's Rifle Challenge requirements and match the Second Amendment Foundation's Training Division requirements,

RESOLVED, the Instructor Upgrade Procedures attached to the meeting agenda are approved for inclusion in the SOP, with the following amendments:

• Requirement for NRA RSO status at the Certified Carbine instructor level

• Requirement at the Certified Carbine instructor level for attendance at an NRA Refuse to be a Victim, NRA Personal Protection in the Home, relevant Military or Law Enforcement experience, or similar defensive training (e.g., CCW)

• Clarification that Instructors are not authorized to provide instruction on the legal considerations in the use of force.

The board discussed budget considerations for calendar year 2017.

The following resolution was approved unanimously:

WHEREAS, the Board considers an ongoing relationship with the NRA to be of value and

WHEREAS, support of Youth Day at the NRA Annual Meeting has shown value to the organization,

RESOLVED, that a budget of up to \$1200 is authorized for support of Youth Day at the 2017 NRAAM, with expenditure details delegated to the Treasurer and appointed project leader.
